ORDER SHORTENING TIME FOR RESPONSES TO COMPLIANCE TARIFF FILING

On March 1, 2024,¹ Missouri-American Water Company (MAWC) filed an application to change its Water and Sewer Infrastructure Rate Adjustment (WSIRA). On June 20, the Commission issued its *Order Rejecting Tariff Sheets and Authorizing WSIRA Rates* (Order) rejecting the previously filed tariff sheets and authorizing MAWC to submit tariff sheets in compliance with the Order.

On June 20, MAWC filed tariff sheets purported to be in compliance with the Order. The submitted tariff sheets carry a 30-day effective date of July 20, and are assigned Tracking Nos. JW-2024-0170 and JS-2024-0171. Concurrently, MAWC filed a Motion for Expedited Treatment, which requests that the tariff sheets be allowed to take effect on July 11.

The Commission will direct the Staff of the Commission (Staff) to file its recommendation as to whether the tariff sheets comply with the Commission's Order. The Commission will also shorten the timeline for other responses.

1. Staff shall file a recommendation as directed in the body of this order no later than June 28.
2. Any other responses to MAWC's compliance filing shall be filed no later than June 28.
3. This order shall be effective when issued.
