Spire seeks permission and approval and a certificate of convenience and necessity ("CCN") to construct, install, own, operate, maintain, and otherwise control and manage natural gas distribution systems throughout the state of Missouri and for approval to acquire natural gas assets of Southern Star Central Gas Pipeline, Inc. Spire also requests a waiver from the notice provisions of Commission rule 20 CSR 4240-4.017(1).

The Commission will direct notice of the application be given by the Commission to the news media. The Commission will set a deadline for interested parties to intervene and set a time for a recommendation or status report from the Staff of the Commission.

### THE COMMISSION ORDERS THAT:

1. The Commission's Public Policy and Outreach Department shall make notice of this order and the application available to the news media in Spire's service territory.

2. Any person wishing to intervene in this matter shall file an application to intervene no later than July 1, 2024. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission. Comments on the application may also be made in EFIS.

3. No later than July 16, 2024, the Staff of the Commission shall file a recommendation regarding Spire's application or a status report indicating when it expects to file a recommendation.

4. This order shall be effective when issued.
