COMES NOW, Co-Mo Electric Cooperative, Inc. and Union Electric Company d/b/a Ameren Missouri (hereinafter “Parties”), by and through the undersigned counsel, and files this Joint Motion for Extension of Time to File Staff’s Recommendation respectfully requesting the Missouri Public Service Commission grant their Joint Motion extending the date for filing Staff’s Recommendation in this proceeding from June 27, 2024 to July 5, 2024.

In support of this motion, the parties state as follows:

1. In its Order Directing Notice, Setting Deadline For Intervention, and Directing Staff Recommendation issued in File No. EO-2024-0331 on May 6, 2024, the Commission ordered Staff to file a recommendation in this case no later than June 27, 2024.
2. The Parties are requesting an additional seven (7) days, or until July 5, 2024, to further analyze the case and potentially reach a settlement agreement that would allow Ameren to provide service to Applicants, as requested.
