**ORDER ACCEPTING STAFF'S STATUS UPDATE AND REQUEST
REGARDING CYCLE 1 CARRY- OVER COSTS PRUDENCE REVIEW**

On October 27, 2016, the Commission's Staff filed a Status Update stating that due to a high workload, it would be difficult for the Energy Resources Department to complete the prudence review of Kansas City Power & Light's (KCP&L's) Cycle 1 carry-over costs during the fall of 2016. The Cycle 1 carry-over costs are costs associated with large commercial projects approved during the review period but not completed until January - June 2016, after the 18 months of the first KCP&L MEEIA Prudence Audit. Staff states that the second KCP&L MEEIA prudence review, although not yet scheduled, must begin no later than January 2018. Staff indicates that the prudence review for the Cycle 1 carry-over costs can be completed in 2017 or early 2018, when Staff performs its second KCP&L MEEIA prudence review. This will allow Staff to perform a more thorough review and will not harm taxpayers.

The Commission will authorize Staff to complete its prudence review of the Cycle 1 carry-over costs during the second KCP&L MEEIA prudence review.

THE COMMISSION ORDERS THAT:

1. Staff shall include its prudence review of Cycle 1 carry-over costs with its second KCP&L MEEIA prudence review.
2. This order shall be effective when issued.
3. This file shall close on November 18, 2016.
