ORDER GRANTING CERTIFICATE TO PROVIDE TELECOMMUNICATIONS SERVICE

On June 21, 2024, Kansas Fiber Network, LLC, filed an application for authorization to provide non-switched local telecommunications (IXC) service in the Kansas City metropolitan area in the State of Missouri, as permitted by Sections 392.611.4 and 392.550, RSMo (2016). Additionally, Kansas Fiber Network, LLC requested waiver of the Commission's sixty-day notice of case filing requirement.

The Commission has reviewed the application filed by Kansas Fiber Network, LLC and finds that it and its attached affidavit comply with the filing requirements set forth in Section 392.550. The affidavit also represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 150 days prior to the filing date of the application.

Pursuant to Section 392.550.3, this order shall be effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Kansas Fiber Network, LLC is granted authority to provide non-switched local telecommunications services in the Kansas City metropolitan area in the State of Missouri.

2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.

3. This order shall become effective on July 6, 2024.
