**ORDER SETTING LOCAL PUBLIC HEARING**

On May 29, 2024, the Commission directed its Staff to consult with the parties in this matter and file a response regarding holding a local public hearing. On June 13, 2024, Staff filed a response recommending a virtual local public hearing take place during one of the following days, July 22 – 26, 2024.

The Commission will now set the virtual local public hearing date and time.

**THE COMMISSION ORDERS THAT:**

1. The virtual local public hearing is scheduled for **6:00 p.m. on Tuesday, July 23, 2024.**
  - a. To attend the virtual local public hearing **by telephone**, at the time of the hearing call toll free 1-855-718-6621, listen to the prompt and enter the meeting number/access code 2634 491 5305, followed by # (pound/hashtag symbol). If prompted for a password, enter 0343.

b. To attend a virtual local public hearing **by video/internet** visit the website at [www.webex.com](http://www.webex.com) or download the Cisco WebEx Meetings application. At hearing time, enter the meeting number/access code 2634 491 5305 and password 0343.

2. The public hearing will begin with a question-and-answer session and formal public comments to the Commission will begin immediately following the conclusion of the question-and-answer session.

3. No later than ten days before the local public hearing, Holtgrewe Farms Sewer Company, LLC and Holtgrewe Farms Water Company, LLC shall provide notice of the public hearing to each of its customers, and shall file a status report with the Commission detailing the notice, and how and when it was delivered.

4. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing.

5. Any person who needs an accommodation to participate in the hearing should call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearing.

6. Written comments may be submitted to the Commission in writing by mailing the comment to the Missouri Public Service Commission, P.O. When submitting comments please reference File No. WR-2024-0343 (water) or File No. SR-2024-0344 (sewer).

7. The Commission's Data Center shall serve a copy of this order upon the county commission for Franklin County, the only county in the service area of Holtgrewe Farms Sewer Company, LLC and Holtgrewe Farms Water Company, LLC.

8. This order shall be effective when issued.
