**ORDER DENYING INTERVENTION**

On February 2, 2024, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed a general rate case with the Commission. The Commission gave public notice of the application and set a February 20, 2024, intervention deadline.

On May 21, 2024, the Federal Executive Agencies (FEA) filed an application to intervene. In its application, FEA stated that it was unaware of the rate case application until after the intervention deadline had passed.

Commission Rule 20 CSR 4240-2.075(10) allows the Commission to grant a motion to intervene after the intervention date "upon a showing of good cause." The Commission finds that FEA being unaware despite the Commission's notice, and that FEA's intervention application being three months late, does not rise to the level of good cause. Consequently, the Commission will deny FEA's untimely application to intervene.

**THE COMMISSION ORDERS THAT:**

1. FEA's application to intervene is denied.

2. This order shall be effective when issued.
