**AMENDED REPORT REGARDING TARIFFS**

COMES NOW MCImetro Access Transmission Services, LLC (MCImetro LLC), an MCI WorldCom company, and pursuant to the Commission's Order Regarding Case Status of July 1, 1999, makes the following Amended Report Regarding Tariffs:

1. On October 27, 1998, the Commission approved MCImetro LLC's application for certificate of service authority in this case.
2. On October 28, 1998, the Commission approved the merger of MCImetro Access Transmission Services, Inc. into MCImetro LLC in Case No. TM-98-576.
3. On February 8, 1999, MCImetro LLC advised the Commission that the merger was completed. At that time, MCImetro Access Transmission Services, Inc. had ceased to exist, however, its original private line tariffs inadvertently remained in its name rather than being formally adopted by MCImetro LLC.
4. On March 2, 1999, MCImetro LLC filed proposed tariffs covering all aspects of its authority including private line services. On May 14, 1999, after several revisions and extensions, MCImetro LLC's tariffs took effect. It was intended that the new tariffs expand upon and replace the existing private line tariff, and MCImetro Access Transmission Services, Inc., never had effective CLEC switched services tariffs. However, the MCImetro LLC tariffs inadvertently contained references to MCImetro

Access Transmission Services, Inc. because they had been initially proposed before the merger had been approved and were involved in discussion and revisions with Staff for an extended period of time.


5. On May 27, 1999, MCImetro LLC filed revised tariffs. The revisions eliminated the inadvertent references to MCImetro Access Transmission Services, Inc. To the extent necessary, if any, these corrective tariffs served as an adoption and republication of the March 2 tariffs. These revised tariffs took effect on June 27, 1999.

6. In specific response to the Commission's order of July 1, 1999, MCImetro LLC states that it has in effect Tariffs Nos. 1 and 2 and intends to continue to provide service under these tariffs. As indicated, MCImetro Access Transmission Services, Inc. never had effective tariffs, other than the original private line tariffs, which have been replaced by the current MCImetro LLC Tariffs Nos. 1 and 2.

7. MCImetro LLC stands ready to provide additional information as needed.


