ORDER GRANTING MOTION FOR EXTENSION OF TIME TO RESPOND, CANCELING TARIFF AND CLOSING FILE

On June 22, 1998, McImetro Access Transmission Services, LLC (MATS, LLC) filed an application for certificates of service authority and competitive classifications. On the same date, MATS, LLC filed an application for approval of a merger with McImetro Access Transmission Services, Inc. (MATS, Inc.). That application was assigned case number TM-98-576. MATS, Inc., was to be merged into MATS, LLC and MATS, Inc., would cease to exist. The Commission approved MATS, LLC's application for certificates of service authority on October 27, 1998. MATS, LLC's Certificate of Service Authority to provide telecommunications services was to become effective when its tariff became effective. MATS, LJC did not initially file its own tariff. But in the Stipulation and Agreement that was approved in Case No. TA-98-575, MATS, LLC indicated that it intended to adopt the tariffs of MATS, Inc., after the merger of those two companies was approved.

The Commission approved the merger of MATS, Inc., into MATS, LLC by an order issued on October 28, 1998 in case number TM-98-576. At the time of the merger, MATS, Inc. had been granted a conditional certificate to provide telecommunications services but its tariff for those services had not yet been approved. The tariff of MATS, Inc. was approved by the Commission in an order issued on May 12, 1999 in case number TA-96-355. However, MATS, LLC did not file a notice adopting the tariffs of MATS, Inc.

Because the Commission was uncertain about the status of the certificates of service authority to provide telecommunications services that were issued MATS, LLC, it issued an order on July 1, 1999, directing MATS, LLC to file a report advising the Commission of its intentions with regard to the tariffs by which it proposes to provide telecommunications services. That Order also directed the Staff of the Public Service Commission (Staff) to file its response to the report of MATS, LLC no later than ten days following the filing of that report.

MATS, LLC filed a Report Regarding Tariffs on July 12. On July 22, Staff filed a Motion for Extension of Time to File Staff Response to Report Regarding Tariffs, which asked that it be allowed until July 29 to file its response. On July 27, MATS, LLC filed an Amended Report Regarding Tariffs. Staff filed its Response to Report Regarding Tariffs and Motion to Cancel Tariff on July 29.

MATS, LLC's Amended Report indicates that MATS, LLC has adopted its own tariffs covering all aspects of its service authority. Those tariffs took effect on June 27, 1999 and MATS, LLC intends to continue to provide

service under those tariffs. Staff's response agrees with the statements in MATS, LLC's Amended Report. Staff also indicates that in Case No. TO-96-344, Access Transmission Services, Inc., changed its name to MATS, Inc., which then adopted the private line tariff of Access Transmission Services, Inc. Although MATS, Inc. has been merged into MATS, LLC and MATS, LLC is operating under its own tariffs, MATS, Inc.'s tariff has not yet been canceled. Therefore, Staff requests that the Commission issue an order canceling Tariff No. 1 of Access Transmission Services, Inc., as adopted by MATS, Inc.

The reports filed by MATS, LLC and Staff have resolved the Commission's questions about the status of this matter. Staff's Motion for Extension of Time to File Response and Staff's Motion to Cancel Tariff will be granted. With the resolution of these questions, this file may now be closed.

IT IS THEREFORE ORDERED:

- 1. That the Motion for Extension of Time to File Staff Response to Report Regarding Tariffs filed on July 22, 1999, is granted.
- 2. That Tariff No. 1 of Access Transmission Services, Inc., as adopted by MCImetro Access Transmission Services, Inc., is canceled.
 - 3. That this order shall become effective on August 20, 1999.

4. That this file may be closed on August 23, 1999.


