On July 25, 2016, the Staff of the Missouri Public Service Commission ("Staff") filed its *Notice of Start of Second MEEIA Prudence Audit*. Staff stated it started its second MEEIA prudence audit of the costs associated with Union Electric Company d/b/a Ameren Missouri's Demand Side Investment Mechanism ("DSIM") for the period July 1, 2014, through December 31, 2105. Staff plans to file a recommendation regarding its examination and analysis no later than December 22, 2016.

Commission Rule 4 CSR 240-20.093(10)(B) establishes a one hundred sixty day deadline of January 1, 2017, for parties to file a request for hearing. Therefore, the Commission will direct notice be provided of Staff's audit and set a deadline for the filing of applications to intervene.

- 2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing the counties within Union Electric Company d/b/a Ameren Missouri's service area, and to the news media serving that service area.
 - 3. Applications to intervene shall be filed no later than September 12, 2016.
 - 4. This order shall become effective when issued.
