APPLICATION FOR NAME CHANGE RECOGNITION

COMES NOW United Services, Inc (United Services”) and respectfully submits this Application for Name Change Recognition pursuant to Title 20§4240-2.060(5) of the Commission’s rules requesting recognition of United Services name change to United Fiber, LLC d/b/a United Fiber M), LLC (collectively, United Fiber”) for its sewer operations.

1) United Services has changed its name to United Fiber, LLC d/b/a United Fiber MO, LLC. United Services requested its name change to be recognized for its non-sewer regulated activities (ETC, I-VoIP and Video Service Authorizations) earlier this year and the Commission recognized its name change in an Order issued March 20, 2024, in DN-2024-6213 and KN-2024-0252.

2) Title 20§4240-2.060(5) of the Commission’s rules provide for the recognition and approval for regulated non-telecom and video purposes and notes that the application shall include:

- (A) A statement, clearly setting out both the old name and the new name;
- (B) Evidence of registration of the name change with the Missouri secretary of state; and
- (C) Either an adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date which is not fewer than thirty (30) days after the filing date of the application.

3) Consistent with the cited rules United Servicers states as follows:

(a) Name Change:

Old Name: United Services, Inc.

New Name: United Fiber, LLC d/b/a United Fiber MO, LLC

(b) Evidence of the Name Change with the Secretary of State: Attached as Exhibit 1 is a copy of the registration filed with the Missouri Secretary of State.

(c) A copy of the adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of this application is attached as Exhibit 2.

WHEREFORE, United Services respectfully submits this Notice of Name Change and requests an Order recognizing the name change for its sewer registrations.



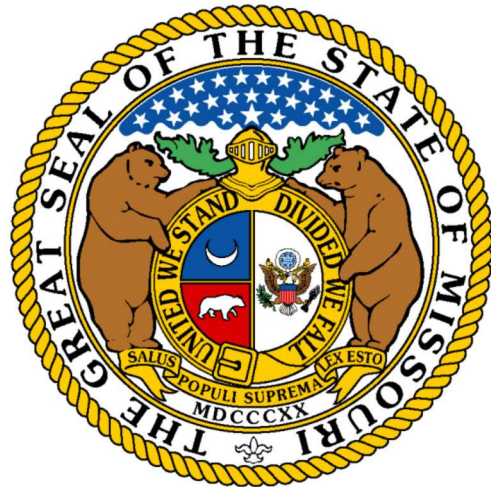
