#### JOINT MOTION FOR EXTENSION OF TIME

**COMES NOW** Missouri-American Water Company ("MAWC"), and the Staff of the Missouri Public Service Commission ("Staff") (together "Movants"), by and through the undersigned counsel, and move for an extension of time for Staff to file a recommendation regarding MAWC's application. In support, Movants state as follows to the Commission:

1. The Commission's Order Directing Staff to File Recommendation and Setting

*Deadline for Responses* directs Staff to file a recommendation regarding MAWC's application no later than July 3, 2024. The Order further directs responses to Staff's recommendation to be filed no later than July 11, 2024.

2. Staff previously sent data requests to MAWC concerning this application.
