**ORDER GRANTING APPLICATION TO INTERVENE**

On April 13, 2017, Kansas City Power & Light Company (KCP&L) filed its 2016 Renewable Energy Standard Compliance Report, as required by Commission Rule 4 CSR 240-20.100(8). The Missouri Industrial Energy Consumers (MIEC) applied to intervene on April 21.

This is not a contested case, and any interested person or entity may file comments regarding KCP&L's report without the necessity of applying to be a party to this proceeding. However, under the Commission's confidential information rule, 4 CSR 240-2.135, confidential information may only be disclosed to a party. Therefore, MIEC must be made a party if it is to see the confidential portions of KCP&L's report.

The Commission finds that allowing MIEC to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant MIEC's application to intervene.

**THE COMMISSION ORDERS THAT:**

1. The Application to Intervene of the Missouri Industrial Energy Consumers is granted.

2. This order shall be effective when issued.
