STAFF'S CORRECTED COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), through the undersigned counsel, and recommends approving the compliance tariff sheets filed by Missouri-American Water Company ("MAWC" or "Company"), bearing effective dates on July 20, 2024.

1. On March 1, 2024, MAWC filed an application requesting the Commission to authorize its Water and Sewer Infrastructure Rate Adjustment (WSIRA) petition. MAWC filed attached tariff sheets assigned Tracking Nos. JW-2024-0120 and JS-2024-0121 to its application.

2. On May 30, 2024, Staff recommended the Commission to reject MAWC's proposed tariff sheets in JW-2024-0120 and JS-2024-0121. Alternatively, Staff recommended the Commission to approve Staff's recommended revenues and authorize MAWC to file revised tariff sheets.¹

3. On May 30, 2024, the Commission issued its *Order Directing Staff Response*. And on June 10, 2024, the Company responded. In its response, the Company stated that it had reviewed Staff's recommendation and did not object to Staff's

¹ Staff's recommended WSIRA surcharge revenues in this docket in the incremental pre-tax revenue amount of \$16,739,071 from St. Louis County water customers, \$3,739,420 from All Other water customers, \$10,842 from Arnold sewer customers, and \$326,600 from All Other sewer customers for a total in this filing of \$20,815,934; and Authorizes MAWC to file revised tariff sheets for each utility, service area, and customer class, as reflected in Staff's Schedules 1 - 4, which generates \$20,815,934.

recommended WSIRA revenues.

4. On June 20, 2024, the Commission rejected tariff sheets Tracking Nos. JW-2024-0120 and JS-2024-0121. In the same filing, the Commission approved the revenues identified in *Staff's Memorandum* and authorized MAWC to file revised tariffs to implement a WSIRA rate for each customer class as reflected in Schedules 1-4 attached to *Staff's Memorandum*.

5. On June 20, 2024, the Company filed its revised tariff sheets assigned Tracking Nos. JW-2024-0170 and JS-2024-0171, and filed its *Motion for Expedited Treatment* (Motion) following the Commission's order. In its *Motion*, the Company requested its tariffs to take effect for service rendered on and after July 11, 2024, or as soon thereafter as is reasonable. The Commission granted the Company's request for expedited treatment in its *Order Shortening Time for Response to Compliance Tariff Filing* (Order).

6. Staff reviewed MAWC's tariff sheets and determined that the following tariff sheets does comply with the Commission's *Order* and recommends approval:

P.S.C. Mo. No. 13 8th Revised Sheet No. RT 11.1, Cancelling 7th Revised Sheet No. RT 11.1; and 8th Revised Sheet No. RT 11.2, Cancelling 7th Revised Sheet No. RT 11.2;

P.S.C. Mo. No. 26 7th Revised Sheet No. RT 11.1, Cancelling 6th Revised Sheet No. RT 11.1, and 7th Revised Sheet No. RT 11.2, Cancelling 6th Revised Sheet No. RT 11.2;

7. Staff attached an affidavit with this pleading verifying its review.

WHEREFORE, for the reasons stated above, Staff recommends that the Commission issue an order approving the tariff sheets referenced in paragraph 6, to be

effective on July 11, 2024, or as soon thereafter as is reasonable; and for such other relief

the Commission finds just and reasonable under the circumstances.
