ORDER SETTING DEADLINES FOR SUBMISSION OF CUSTOMER DATA

Issue Date: June 28, 2024

Effective Date: June 28, 2024

On May 22, 2024,¹ the Commission ordered Evergy Metro, Inc. d/b/a Evergy Missouri Metro, and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, “Evergy”) to file a pleading no later than June 12 stating the individual dates when Evergy can provide the information for each of Data Sets 2, 3, 4, 7, 8a, 8c(2), 8c(3), and 8c(4).²

Parties were given until June 18 to respond to Evergy’s proposed due dates.³ The Staff of the Commission (Staff) responded to Evergy’s proposed due date filing, particularly requesting the change of delivery of customer counts⁴ from July 1 to August 2. Staff explained that August 2 coincides with the due date for true-up data in Evergy Missouri West’s pending general rate proceeding, File No. ER-2024-0189. No other responses were filed.

On June 25, Evergy filed its response to Staff’s response. Evergy’s response agreed to Staff’s requested change in due dates from July 1 to August 2 for the customer count data.

The Commission has considered the pleadings of both Evergy and Staff. The Commission finds the dates as proposed by Evergy, with the July 1 due date for customer counts moved to August 2, to be reasonable and will order them.

THE COMMISSION ORDERS THAT:

1. Evergy shall file the information for each of Data Sets 2, 3, 4,⁵ 8c(2), 8c(3), and 8c(4) on the dates as follows:

Data Set 2	August 2, 2024
Data Set 3	August 2, 2024
Data Set 4	July 24, 2024
Data Set 5 ⁶	July 24, 2024
Data Set 8c(2)	August 2 and July 24 as applicable
Data Set 8c(3)	September 6, 2024
Data Set 8c(4)	September 6, 2024.

2. This order shall be effective when issued.
