## NOTICE OF DEFICIENCY AND ORDER DIRECTING FILING

On August 10, 2017, the Commission issued an *Order Setting Procedural Schedule and Other Procedural Requirements*, which required Brandon Jessip to file his direct testimony on August 23, 2017. Mr. Jessip submitted testimony on that date, but the testimony was not in compliance with Commission Rule 4 CSR 240-2.130. That rule requires that all testimony shall be taken under oath, and the prepared testimony of each witness shall be accompanied by an affidavit providing the witness' oath. Mr. Jessip's submitted testimony was not sworn under oath with an affidavit as required by the rule. The Commission will direct Mr. Jessip to file an affidavit to accompany his testimony, a sample of which is attached to this order as Exhibit A.




