Joshua Michael Kearney filed a Complaint on November 17, 2023 before the Commission. On June 24, 2024 attorneys for the Complainant filed a Second Amended Complaint which included no new issues. Under 4 CSR 4240-2.080(18), a complaint may be amended within 10 days of filing, and this Amended Complaint has been filed out of time. This Complainant must have the permission of the Commission to file this amended pleading out of time. To respect the due process rights of the Complainant, the filing will be allowed. The trial date and the procedural schedule will remain the same. Any response to the Second Amended Complaint should be filed within seven days of this order.

The Complainant has ten days to comply with all the requirements of the procedural schedule.

1. The Commission will accept the untimely filing entitled Second Amended Complaint.

2. Any response to the Second Amended Complaint shall be filed no later than July 8, 2024.

3. All the requirements of the Procedural Schedule shall be filed no later than July 11, 2024.
