ORDER EXTENDING STAFF RECOMMENDATION AND RESPONSES DEADLINES

On May 31, 2024,¹ Missouri-American Water Company (MAWC) filed an application requesting authority to engage in a variety of secured debt financings with the Missouri Department of Natural Resources, to be secured by placing a mortgage upon its property. On June 3, the Commission directed its Staff to file a recommendation regarding the application no later than July 3 and set a deadline of July 11 for responses to Staff's recommendation.

On June 28, MAWC and Staff filed a *Joint Motion for Extension of Time* regarding the deadlines, citing delays responding to Staff data requests by MAWC "due to the press of other matters and some internal communication issues."

The Commission finds the motion to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The *Joint Motion for Extension of Time* is granted.
2. No later than August 5, 2024, Staff shall file a recommendation regarding MAWC's application, or a request for additional time to file its recommendation.

¹ Unless otherwise noted, all dates refer to the year 2024.

3. Responses to Staff's recommendation shall be filed no later than August 13, 2024.

4. This order shall be effective when issued.
