**ORDER SETTING TIME FOR OBJECTIONS**

The Commission held an evidentiary hearing in WO-2024-0036 on October 25-26, 2023. The Commission recently held an evidentiary hearing in WC-2023-0353. Commission Rule 20 CSR 4240-2.110(3) permits the Commission to consolidate cases that involve related questions of law or fact. These cases involve the same parties and have similar facts and questions of law. Accordingly, the Commission is considering consolidating these cases.

The Commission will set a deadline for any objections to the Commission consolidating WO-2024-0036 into WC-2023-0353.

**THE COMMISSION ORDERS THAT:**

1. Any party wishing to object to the Commission consolidating WO-2024-0036 into WC-2023-0353 must file an objection no later than July 17, 2024.

2. This order is effective when issued.
