ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On July 1, 2024, Spire Missouri Inc. (Spire Missouri) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheet assigned Tracking Number JG-2025-0003. Spire Missouri projected that the changes to the WNAR tariff sheet will increase the monthly bill of the average Spire East residential customer by \$2.83 per month. For the average Spire West residential customer, the increase is \$1.90 per month. The tariff sheet bears a September 1, 2024, effective date.

The Staff of Commission (Staff) will be directed to file a recommendation. The Commission will establish a deadline for any other entity to file a response to the proposed tariff changes or to the Staff recommendation.

THE COMMISSION ORDERS THAT:

1. No later than August 2, 2024, Staff shall file a recommendation regarding Tracking No. JG-2025-0003.
2. Any responses to Spire Missouri's application or Staff's recommendation shall be filed no later than August 8, 2024.
3. This order is effective when issued.
