On February 13, 2024, the Commission directed its Staff (Staff) to file a monthly status report about Leon Travis Blevins' engagement with the Missouri Department of Natural Resources (DNR). On July 2, 2023, Staff filed a motion asking the Commission to waive the filing of a July status report. The Commission held a hearing on June 24-25, 2024, in File No. WC-2023-0353, which also concern's water systems operated by Blevins.
