**ORDER APPROVING COMPLIANCE TARIFF SHEETS  
AND GRANTING EXPEDITE REQUEST**

Issue Date: July 3, 2024

Effective Date: July 11, 2024

On March 1, 2024,<sup>1</sup> Missouri-American Water Company (MAWC) filed a petition, including tariff sheets, to change its water and sewer infrastructure rate adjustments (WSIRA). On June 20, the Commission issued its *Order Rejecting Tariff Sheets and Authorizing WSIRA Rates* (Order). The Order authorized MAWC to file tariff sheets in compliance with the Order.

On June 20, MAWC filed tariff sheets, assigned Tracking Nos. JW-2024-0170 and JS-2024-0171, with a 30-day effective date of July 20. MAWC stated it filed the tariff sheets in compliance with the Order. MAWC also requested expedited treatment such that the tariff sheets would become effective on July 11, or as soon thereafter as reasonable. In compliance with Commission Rule 20 CSR 4240-2.080(14), MAWC states it requested expedited treatment as the tariff sheets are filed subsequent to a Commission

order directing filing of such compliance tariff sheets, that the implementation is in accordance with Sections 393.1500 through 393.1509, RSMo (Supp. 2023), and that the subject plant has been placed into service and is currently used and useful.

The Commission issued notice and set a time for responses regarding the compliance tariffs and the request for an expedited effective date. On June 28, the Staff of the Commission (Staff) filed its Recommendation that the Commission approve the tariff sheets and grant the expedite request. No objections to the request for expedited treatment were received, and no responses to the tariffs other than Staff's were received.

Upon reviewing the pleadings, the Commission finds MAWC's proposed tariffs filed on June 20 comply with the Commission's Order and will approve them. Pursuant to Section 393.140(11), RSMo, the Commission finds good cause to expedite the effective date of these tariff sheets for the reasons provided by MAWC and the absence of objections to the request. To allow this expedited treatment, the Commission finds it reasonable to make this order effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff sheets filed by MAWC on June 20 and assigned Tracking Nos. JW-2024-0170 and JS-2024-0171 are approved to become effective on July 11. The specific tariff sheets approved are as follows:
