**ORDER DIRECTING STAFF TO FILE RECOMMENDATION
ON COMPLIANCE FILING**

On February 17, 2022, the Commission issued its *Order Approving Unanimous Stipulation and Agreement and Approving Application for Financing Authority* (Order). On June 28, 2024, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed *Evergy Missouri West’s Compliance Filing*, stating that, on May 29, 2024, it had issued \$300 million aggregate principal amount of its 5.650% Mortgage Bonds, Series 2024 due June 1, 2034.

Paragraph 8.ii. of the Unanimous Stipulation and Agreement approved by the Commission in its Order states the following:

That the Company [Evergy Missouri West] shall file with the Commission within thirty (30) days of issuance of any financing secured by the Mortgage Indenture authorized pursuant to a Commission order in this proceeding, a report including the amount of secured indebtedness issued, date of issuance, interest rate (initial rate if variable), maturity date, redemption schedules or special terms, if any, use of proceeds, estimated expenses, and loan or indenture agreement concerning each issuance[.]

The Commission will direct its Staff to file a recommendation advising the Commission as to whether the filing complies with the Order and, if so, whether the file in this matter is ready to be re-closed.

THE COMMISSION ORDERS THAT:

1. No later than July 19, 2024, Staff shall file a recommendation as to whether the information in *Evergy Missouri West's Compliance Filing*, filed on June 28, 2024, and the accompanying attachments complies with the Commission's *Order Approving Unanimous Stipulation and Agreement and Approving Application for Financing Authority*, issued on February 17, 2022.
2. No later than July 19, 2024, Staff shall inform the Commission as to whether the file in this matter is ready to be re-closed.
3. This order shall be effective when issued.
