## ORDER DIRECTING STAFF TO FILE RECOMMENDATION ON COMPLIANCE FILING

On April 10, 2024, the Commission issued its *Order Approving Stipulation and Agreement and Cost Allocation Manual* (Order). On June 24, 2024, Spire Missouri Inc. d/b/a Spire filed a *Notice of Filing*, stating that, in compliance with the Order, it was filing a revised and updated services and facilities agreement, attached to the notice. The attachment to the notice was titled, “Amended and Restated Services and Facilities Agreement” and dated June 7, 2024.

Paragraph 6 of the Full and Unanimous Stipulation and Agreement approved by the Commission in its Order states the following:

Incorporated into the CAM [Cost Allocation Manual] is the Shared Facilities Agreement (“SFA”) between Spire Missouri and its affiliates, however, Spire Missouri will be updating its current SFA. The Parties agree that a revised SFA will be filed within 60 days of the Commission approving this Stipulation.

The Commission will direct its Staff to file a recommendation advising the Commission as to whether the filing complies with the Order and, if so, whether the file in this matter is ready to be re-closed.

**THE COMMISSION ORDERS THAT:**

1. No later than July 24, 2024, Staff shall file a recommendation as to whether the information in the Amended and Restated Services and Facilities Agreement filed by Spire on June 24, 2024, complies with the Commission's *Order Approving Stipulation and Agreement and Cost Allocation Manual*, issued on April 10, 2024.
2. No later than July 24, 2024, Staff shall inform the Commission as to whether the file in this matter is ready to be re-closed.
3. No later than July 24, 2024, any other party may file a response regarding the closing of this file.
4. This order shall be effective when issued.
