ORDER FURTHER SUSPENDING TARIFF

On March 28, 2024, Union Electric Company d/b/a Ameren Missouri filed tariff sheets to extend the Charge-Ahead Business Solutions pilot program for an additional two years. Those tariff sheets bore an effective date of April 27, 2024. The Commission's Staff (Staff) filed a recommendation to reject the tariff sheets. On April 18, 2024, the Commission issued an order suspending Ameren Missouri's tariff sheets until July 26, 2024.

On May 30, 2024, the Commission held a procedural conference. At that conference the parties agreed to resolve the issues before the Commission by filing a stipulation of undisputed facts and two rounds of briefs. The parties filed initial briefs on June 28, 2024, and reply briefs will be filed July 9, 2024.

Unless the Commission takes action to further suspend the tariff sheets, Tracking No. JE-2024-0131, they will go into effect when their suspension period ends on July 26, 2024. Therefore, the Commission will suspend that tariff for an additional sixty days to allow time for the Commission to process the parties' briefs and issue an order about whether to extend the Charge-Ahead Business Solutions pilot program for an additional two years.

THE COMMISSION ORDERS THAT:

1. The tariff sheets submitted by Ameren Missouri on March 28, 2024, assigned Tracking No. JE-2024-0131, previously suspended until July 26, 2024, are further suspended until September 24, 2024.
2. This order shall be effective when issued.
