**ORDER CANCELING EVIDENTIARY HEARING AND DIRECTING THE  
PARTIES TO PROVIDE AVAILABILITY FOR AN AUGUST HEARING**

On July 8, 2024, Complainant Nancy Hurt emailed the Regulatory Law Judge and other parties requesting that the evidentiary hearing currently set for July 11 and 12, 2024, be continued to a future date. The Commission will treat Hurt’s email as a motion for a continuance. Hurt supports her motion by stating that she is unable to provide documentary exhibits to other parties and the Commission by July 10, 2024, as directed.

Hurt proposed several dates in September or October for an evidentiary hearing, but those dates conflict with other scheduled hearings. Accordingly, the Commission will direct the parties to submit their availability for an evidentiary hearing the week of August 19-13, 2024.

The Commission will grant Hurt’s motion and cancel the evidentiary hearing currently set for July 11 and 12, 2024, and will reset the evidentiary hearing by separate order.

**THE COMMISSION ORDERS THAT:**

1. Hurt's motion for a continuance is granted. The evidentiary hearing scheduled for July 11 and 12, 2024, is canceled.
2. No later than July 17, 2024, the parties shall submit their availability for an evidentiary hearing the week of August 19-23, 2024.
3. This order is effective when issued.

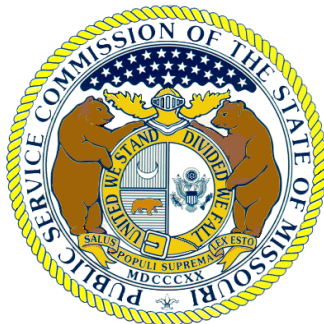
