ORDER DIRECTING NOTICE, SETTING AN INTERVENTION DEADLINE, AND DIRECTING STAFF TO FILE A PLEADING

On July 5, 2024, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application with the Missouri Public Service Commission requesting that the Commission grant them a Certificate of Convenience and Necessity (CCN) to construct, install, own, operate, maintain and otherwise control and manage a water system and a sewer system for the public in an area of Lincoln County, Missouri. The requested CCN would allow Confluence Rivers to extend its water and sewer service to this area from the adjacent Glenmeadows area, which is already serviced by Confluence Rivers.

Confluence Rivers requested to consolidate the files (File Nos. WA-2025-0012 and SA-2025-0013) because the cases will reference identical parties, contain common questions of law or fact, will contain primarily the same filings, and for ease of filings and discovery.

Confluence Rivers has also requested a waiver of the 60-day notice requirement for good cause shown, having had no communication with the Commission within the prior 150 days regarding substantive issues likely to be in this case, other than those pleadings filed of record.

The Commission will direct that notice be given, set a deadline for intervention requests, and order Staff of the Commission to file a pleading.

THE COMMISSION ORDERS THAT:

- The Commission's Data Center shall provide a copy of this order to the County Commission of each county in Confluence Rivers's service territory.
- 2. The Commission's Public Policy and Outreach Division shall make notice of this order available to the media serving each county in Confluence Rivers's service area.
 - 3. Any application to intervene shall be filed no later than July 24, 2024.
- 4. No later than July 30, 2024, the Commission's Staff shall file a pleading indicating when it can file a recommendation regarding Confluence Rivers's application.
 - 5. This order shall be effective when issued.
