On May 24, 2024,¹ Summit Natural Gas of Missouri, Inc. (SNGMO) filed an application requesting an expansion and continuation of its Pilot Meter Sampling Testing Program. The Commission directed a recommendation or a status report from its Staff (Staff) no later than July 10. Staff timely filed a request for an extension of time to submit its recommendation.

Staff requested an extension until July 26 to continue its review, receive responses to data requests, and draft its recommendation. The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time is granted. Staff shall submit its recommendation or a further status report no later than July 26, 2024.
2. This order shall be effective when issued.
