## ORDER RESCINDING STAFF RECOMMENDATION DIRECTION

On May 24, 2024,<sup>1</sup> Union Electric Company d/b/a Ameren Missouri filed an application requesting a certificate of convenience and necessity.

On May 29, the Commission issued its *Order Directing Notice, Setting Intervention Deadline, and Directing Staff Recommendation* (Order), which, among other things, directed the Staff of the Commission (Staff) to file a recommendation regarding Ameren Missouri's application, or a status report, no later than July 12.

On June 17, all parties in this matter<sup>2</sup> filed a *Joint Motion to Adopt Procedural Schedule*. Given the parties' motion, the Commission will rescind the portion of its May 29<sup>th</sup> Order directing Staff to file a recommendation regarding Ameren Missouri's application.

### THE COMMISSION ORDERS THAT:

1. The portion of the Commission's Order, issued on May 29, 2024, directing Staff to file a recommendation regarding Ameren Missouri's application, or a status report, is rescinded. Staff is no longer required to file a recommendation or status report.
