ORDER TO SHOW CAUSE

On March 18, 2024, Sullivan Development Properties, LLC (Sullivan) filed an application with the Missouri Public Service Commission (PSC) requesting a change of electric supplier from Union Electric Company d/b/a Ameren Missouri (Ameren) to Farmington, Missouri City Light and Water (Farmington). On May 3, 2024 the City of Farmington filed a Response to the Sullivan Development application for a change of electric supplier, recommending the Commission either deny or stay the application Sullivan filed. On May 3, 2024 Ameren filed a response to the Sullivan application, recommending the Commission deny the application. On May 23, 2024 Staff filed a Status Report and Recommendation requesting the Commission either stay the Order requiring the status report or order Sullivan, Ameren, and Farmington to confer and file a status report with the Commission.

A prehearing conference was held on July 10, 2024 and the conference was attended by counsel for the City of Farmington, counsel for Ameren, and Staff Counsel for the PSC. Counsel for the Applicant failed to appear. The attendees of the Prehearing conference filed pleadings stating that the Commission has no power to order the relief the Applicant seeks. Non attendance at the pre hearing conference is grounds for dismissal under 20 CSR 4240-2.110. In this instance, the Applicant failed to seek a continuance and did not appear. In

order to prevent dismissal of this application, the Applicant must file pleadings showing why this application should not be dismissed.

In addition, if a hearing is sought all parties and intervenors should forward available trial dates beginning in December of 2024.

THE COMMISSION ORDERS THAT:

1. The Applicant shall file pleadings that show why this application should not be dismissed by July 17, 2024.
2. By July 22, 2024 all parties shall file available hearing dates for December 2024.
3. This order shall be effective when issued.
