**SPIRE MISSOURI’S REQUEST FOR ADDITIONAL TIME  
TO FILE AN ANSWER OR STATUS UPDATE**

COMES NOW Spire Missouri Inc. (“Spire Missouri” or the “Company”) and respectfully submits this *Request for Additional Time to File an Answer or Status Update* to the Missouri Public Service Commission (“Commission”), stating the following:

1. On March 25, 2024, Staff of the Missouri Public Service Commission (“Staff”) filed a Formal Complaint as a follow-up to its investigation in Docket No. GS-2022-0047.
2. On March 28, 2024, the Commission directed Spire Missouri to file an answer to the Formal Complaint no later than April 29, 2024.
3. On April 22, 2024, Spire Missouri filed a request for additional time to file its Answer or a status update. The Commission granted this request and ordered Spire Missouri to file an answer or a status update no later than June 3, 2024.
4. On May 31, 2024, Spire filed a request for additional time to file its Answer or a status update. The Commission granted this request and ordered Spire Missouri to file an answer or a status update no later than July 15, 2024.
5. Spire Missouri is working with a third-party to develop the sampling program recommended by Staff. Spire Missouri has received a draft of this program, and after follow-up with the third-party, the Company will meet with Staff to review and discuss the proposed

sampling program. Additional time is needed to both meet with the third-party and then meet with Staff. Spire Missouri requests that the Commission order Spire Missouri to file an answer or status update no later than July 31, 2024. Staff has been notified of the request and does not object.

**WHEREFORE**, Respondent respectfully requests that the Commission grant Spire Missouri's request and order the Company to file its Answer or a status update no later than July 31, 2024, and order any other relief as is just and reasonable.
