On June 27, 2024,¹ United Services, Inc. requested that the Commission recognize its name change to United Fiber, LLC d/b/a United Fiber MO, LLC. The Commission directed the Staff of the Commission (Staff) to file a recommendation no later than July 11.

Staff reports that it and United Services, Inc. have engaged in productive discussions, and requests a four-day extension of time, to July 15, 2024, to file its recommendation. Staff's motion indicates that United Services, Inc. does not object to this request.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation or further status report regarding United Services, Inc.'s request no later than July 15, 2024.
