## ORDER AMENDING PROCEDURAL SCHEDULE

Issue Date: July 12, 2024

Effective Date: July 12, 2024

On February 16, 2024,<sup>1</sup> the Commission issued its *Order Setting Procedural Schedule*. On May 30, the Commission issued its *Order Amending Procedural Schedule* to adjust the deadlines for rebuttal and surrebuttal testimony.

On July 11, Union Electric Company d/b/a Ameren Missouri filed a *Motion to Amend Procedural Schedule* stating that, although the procedural schedule ordered by the Commission calls for a Joint Statement of Facts to be filed by July 11, “[b]ased upon recent discovery and the positions of the parties reflected in pre-filed testimony, it is not practical to obtain agreement on a meaningful set of agreed upon facts that would be an aid to the Commission in this case.” Therefore, Ameren Missouri requests that the Commission amend the procedural schedule to dispense with the filing of a Joint Statement of Facts. The other parties in this matter agree with Ameren Missouri’s motion.

The Commission finds the unopposed motion reasonable and will grant the motion.
