**ORDER GRANTING ADDITIONAL TIME
TO FILE ANSWER TO COMPLAINT**

On March 25, 2024,¹ the Staff of the Commission (Staff) filed a complaint against Spire Missouri Inc. d/b/a Spire alleging violation of certain sections of the Commission’s gas safety rules. The Commission directed Spire to file an answer to the complaint.

On April 29, at Spire’s request, the Commission extended the time for Spire to file an answer to the complaint, or a status report, to June 3. The Commission did so again on May 31, extending the time to file an answer to July 15.

On July 11, Spire filed a *Request for Additional Time to File an Answer or Status Update*, stating that additional time is needed to further develop a sampling program recommended by the Staff of the Commission. As with Spire’s previous requests, Staff does not object to Spire’s current request.

The Commission will grant Spire’s request.

¹ Unless otherwise noted, all dates refer to the year 2024.

THE COMMISSION ORDERS THAT:

1. Spire's request for additional time to file an answer to Staff's complaint is granted.
2. Spire shall file an answer to the complaint, or a status report, no later than July 31, 2024.
3. This order shall be effective when issued.
