At its March 22, 2017 agenda meeting, the Commission issued its *Order Granting Authority to Continue Serving as a 2-1-1 Information and Referral Service Provider* (the "Order"). As requested by the Commission's Staff, the Order requires all certificated or registered telecommunications companies and IVoIP providers reconfigure their switches so that local callers may reach the United Way of Greater St. Louis by dialing 211. The Order is set to go into effect on April 17, 2017.

On March 23, Staff filed an Amended Staff Recommendation, requesting the Commission "order deletion of the final sentence of the prayer in its Recommendation filed on January 27, 2017." Since the Order was issued based on Staff's initial Recommendation, the Commission will direct Staff to submit a statement clarifying if the only request before the Commission is to revise the language in Staff's Recommendation or if Staff is instead requesting the Commission amend the Order to remove the requirements of Ordered Paragraph 2.

THE COMMISSION ORDERS THAT:

- 1. No later than March 24, 2017, Staff shall submit a filing as described in the body of this order.
 - 2. This order shall be effective when issued.
