ORDER DIRECTING JOINT PROPOSED PROCEDURAL SCHEDULE

On May 24, 2024, Union Electric Company d/b/a Ameren Missouri filed an application requesting a certificate of convenience and necessity.

On June 17, all parties in this matter¹ filed a *Joint Motion to Adopt Procedural Schedule*. The Commission has a conflict on the suggested evidentiary hearing dates. Therefore, the Commission will direct the parties to file a new proposed procedural schedule on an expedited basis.

THE COMMISSION ORDERS THAT:

1. No later than July 19, 2024, Staff, or another party, shall file a joint proposed procedural schedule on behalf of all parties or request an extension of time to do so.
2. This order shall be effective when issued.
