**ORDER GRANTING STAFF MOTION FOR AN EXTENSION OF TIME TO
FILE A STAFF RECOMMENDATION**

On June 6, 2024, Spire Missouri, Inc. d/b/a Spire filed an application requesting a Certificate Of Convenience and Necessity (CNN) to construct, install, own, operate, maintain and otherwise control and manage natural gas distribution systems throughout the State of Missouri and for approval to acquire natural gas assets of Southern Star Central Gas Pipeline Inc.; And requesting a waiver from the notice provisions of Commission Rule 20 CSR 4240-4.017(1). On June 21, 2024, the Commission issued an Order And Notice directing staff to file a recommendation regarding Spire’s application or a status report when it expects to file a recommendation no later than July 16, 2024.

On July 15, 2024 Staff filed a Motion For An Extension Of Time To File A Recommendation asking for a sixty day extension to conduct further discovery, analyze required data and information from Spire, and complete its investigation. Staff stated in their Motion that they did not intend to delay or hinder the proceedings and that counsel for Spire in the Office of Public Counsel did not object to the granting of an extension of time.

THE COMMISSION ORDERS THAT:

1. The Commission shall grant Staff's motion for an extension of time. Staff shall file a recommendation by September 16, 2024.
2. This order shall be effective when issued.
