CORRECTED ORDER SETTING LOCAL PUBLIC HEARINGS

Issue Date: July 19, 2024 Effective Date: July 19, 2024

This order, originally issued July 18, 2024, misstated the access code for the WebEx virtual local public hearings in ordered paragraph 6a. The access code is corrected in this order.

On March 13, 2024, Liberty Utilities (Missouri Water) Corp. d/b/a Liberty filed proposed tariff sheets to increase its annual revenues by a total of an additional \$7,990,089 in annual water revenues and an additional \$75,178 in annual sewer revenues. The Commission directed the parties to submit proposed details for local public hearings. The Commission's Staff (Staff) submitted proposed locations for eight in-person local public hearings and two virtual public hearings. Liberty proposed that the Commission limit the number of local public hearings to four in-person hearings and two virtual public hearings. The Commission will set six in-person local public hearings and two virtual public hearings.

THE COMMISSION ORDERS THAT:

1. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the

beginning of each local public hearing. Comments to the Commission from the public will begin at the conclusion of the question and answer session.

- 2. Liberty, Staff, and the Office of the Public Counsel shall make a representative available to address substantive issues during the question-and-answer sessions. Any other party may also choose to have a representative present.
- 3. No later than ten days before the virtual public hearings, Liberty shall provide notice of the hearings to each of its customers. The parties must jointly file agreed upon language to be included in the local public hearing notices no later than July 26, 2024.
- 4. Any person may participate at any of the hearings, but are encouraged to attend the hearing closest to their service area for the most relevant information. Testimony at each hearing will be limited to five minutes per person.
