**JOINT RECOMMENDATION FOR PROCEDURAL SCHEDULE**

COME NOW the Parties to this proceeding, and in compliance with the Commission's Order, dated March 16, 1999, Setting Pre-Hearing Conference and Requiring Filing of Procedural Schedule, submit the following proposed procedural schedule. In support of their request that the Commission adopt this procedural schedule, the Parties state the following:

1. On February 3, 1999, the Missouri Coalition for Fair Competition (hereinafter "Coalition") filed a Complaint against the Respondent, Union Electric Company, d/b/a as AmerenUE (hereinafter "UE"). This case is designated as Case No. EC-99-327. The Complaint alleges, among other things, that UE violated § 386.754-764 RSMo Cum. Supp. 1998 by offering an HVAC service to customers without a disclaimer stating that the service offered is not regulated by the Missouri Public Service Commission.

2. On March 8, 1999, UE filed its Answer to the Complaint of MCFC. UE acknowledged that it inadvertently allowed references to a non-regulated service to appear on its bill without the required disclaimer. In its Answer, UE asked the Commission to dismiss the complaint.

3. In its March 16, 1999, Order, the Commission directed the parties to hold a prehearing conference on March 26, 1999, to establish, among other things, a proposed procedural schedule.

4. As a result of discussions at the prehearing conference, the parties have agreed upon and respectfully request that the Commission adopt the following procedural schedule:


**PROPOSED PROCEDURAL SCHEDULE**

Direct Testimony to be filed by complainant - Coalition	June 1, 1999
Rebuttal Testimony to be filed by all other parties	June 16, 1999
Surrebuttal or Cross-Surrebuttal to be filed by all parties	June 30, 1999
Hearing Memorandum	July 15, 1999
Evidentiary Hearing	July 22, 1999

**WHEREFORE**, the parties to this case respectfully request that the Commission issue an Order adopting the foregoing proposed procedural schedule.




