COMES NOW Staff of the Missouri Public Service Commission, by and through the undersigned counsel, and for its Response to *Order Directing Staff to File Recommendation on Compliance Filing* ("Response") respectfully states as follows:

- 1. On July 3, 2024, the Commission issued an *Order Directing Staff to File Recommendation on Compliance Filing* ("Order") in which it directed Staff to, no later than July 19, 2024: (a) file a recommendation as to whether the information in *Evergy Missouri West's Compliance Filing*, filed on June 28, 2024, and the accompanying attachments, complies with the Commission's *Order Approving Unanimous Stipulation and Agreement and Approving Application for Financing Authority*, issued on February 17, 2022, and (b) inform the Commission as to whether the file in this matter is ready to be re-closed.
- 2. In regard to (a) above, based on information currently known by and available to Staff, Evergy Missouri West's ("EMW") compliance filing, filed on June 28, 2024, and the accompanying attachments, appear to comply with the Commission's *Order Approving Unanimous Stipulation and Agreement and Approving Application for Financing Authority* issued on February 17, 2022.¹
