## ORDER DIRECTING RECOMMENDATION ON REVISED TARIFF

On July 18, 2024, the Commission issued an Order Granting Certificate of *Convenience and Necessity* (CCN) in this matter, effective August 17, 2024. The order granted Spire Missouri, Inc., d/b/a Spire, a CCN to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Newton County, Missouri, as a further expansion of its existing certificated area.

The CCN was granted subject to certain conditions listed in Paragraph 2 of the order. Paragraph 2.a. states, "Spire shall file an updated tariff sheet incorporating Section 16 and Section 17, Township 26 North, Range 33 West of Newton County as part of its certificated area."

On July 19, 2024, Spire filed a revised tariff sheet, bearing an effective date of August 18, 2024, and assigned Tracking No. JG-2025-0009, purporting to comply with the Commission's July 18<sup>th</sup> order.

The Commission will ask its Staff to file a recommendation advising the Commission as to whether the submitted revised tariff sheet complies with the Commission's July 18<sup>th</sup> order.

### THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Spire's revised tariff sheet (Tracking No. JG-2025-0009) no later than July 29, 2024.

2. This order shall be effective when issued.
