ORDER EXTENDING DEADLINE TO FILE STAFF INVESTIGATIVE REPORT

Issue Date: July 19, 2024 Effective Date: July 19, 2024

On August 10, 2023, the Commission issued an order establishing a case for purposes of receiving an investigative report from the Commission's Safety Engineering Department regarding an incident on July 17, 2023, involving the release and ignition of natural gas in Springfield, Missouri in an area serviced by the municipal gas system of City Utilities of Springfield (CU). The Commission set a deadline for the Staff of the Commission (Staff) to file an investigative report regarding the incident or a status report. At the request of Staff, the deadline has subsequently been extended there times, most recently to July 19, 2024.

On July 17, 2024, Staff filed a *Status Report* in which it stated that CU's failure investigation is still not completed. CU has enlisted a third party to conduct a root-cause analysis to determine the cause of the incident. That third party's analysis is ongoing with no estimated completion date. Consequently, Staff has requested a further extension to file its investigative report, or a report on the status of the investigation.

The Commission will grant Staff's request.

THE COMMISSION ORDERS THAT:

- 1. Staff shall file its report regarding the July 17, 2023, incident described in the body of this order or a report on the status of its investigation no later than October 24, 2024.
 - 2. This order shall be effective when issued.
