Notice is given that **Brett Felber** appeals from a Public Service Commission order or decision entered in this action on **11/29/2023** (date).

### Brief Description of Case (May be completed on a separate page)

Ameren Missouri committed an illegal disconnection of services on May 14, 2023. Payment agreement (see attached) was for May 22, 2023. Ameren Missouri was allowed to use a counterfeit agreement (see attached / exhibit 1) page 2 is the counterfeit document Ameren used with a bogus email address that is affixed to a website at [www2.ameren.com](http://www2.ameren.com). Payment agreement terms are invalid etc. Ameren Missouri and counsel admitted during evidentiary hearing to altering documents and that they didn't keep a copy of the agreement.

I was denied any due process, as the Regulatory Judge denied any reconnection of service after Ameren Missouri openly admitted to altering documents and I raised awareness of the documents that were confident.

I was denied any and all motions for discovery. During the evidentiary hearing not only did staff lie, but also Ameren Missouri. Ameren used an audio document to seek proof of payment agreement which failed to state a date of payment and amount. Ameren Missouri changed the sourcing link of audio date labeled May 18, 2020 and when further questioned by I about the audio Ameren Missouri. Ameren Missouri along with PSC Staff openly admitted that the audio didn't have the actual date or amount due.

Attached is also a letter from Sand Grid's Parent Company Twilio, stating that the payment agreement I submitted was the actual payment agreement. (see attached document with Notary Affidavit)



Ameren Missouri, along with the employees, their legal counsel, Commission, Staff, Regulatory Judge had the option to render the correct decision, but they enacted themselves to fraud, more importantly counterfeit documents. To defraud, Mislead, misrepresent the Complainant

There was no check that was returned. Ameren Missouri's treasury department failed to respond to my bank regarding the payments. Mrs. Krcmar and Mrs. Hernandez were giving a screenshot copy showing the payment was deducted from my bank (Discover Bank) in April.

Maybe Mrs. Hernandez could start being truthful and attach the copy of the screenshot I gave her and her and Aubrey Krcmar that shows the payment cleared. The same payment that Ameren Missouri's treasury department failed to respond to.

As for the certified letter. That was sent to official demand from Ameren Missouri therefore I could start the process of civil and criminal litigation from them. I simply needed to send a copy of materials, that in which Ameren Missouri further failed to respond to. Showing a refusal. Ameren refused to accept responsibility for the counteffeit document and other numerous documents that were inserted.

In fact, Mrs. Hernandez should post all pages of the certified letter, therefore we can compare which pages she is leaving out. Yes it was in fact addressed to Martin Lyons and Mrs. Hernandez. Two of the biggest Con Artists out there.

Notice Mrs. Hernandez deflects the part of meter tampering as well, because they know it's the truth.

I really wish the Commission would recommend once in a while factual data to be insterted into these things, suchs as daily meter readings that can be done via smart meters. That is the whole concept of smart meters. To give better transparency. Something Mrs. Hernandez doesn't want.

I'll post a copy of the filing that I intend to send off to the Court of Appeals Monday.

Maybe Mrs. Hernandez can kinbdly submit a copy of the email that was sent to her and Aubrey Krcmar, along with the document that showed from my bank that is cleared and was cashed by Ameren Missouri. It was sent in an email directly to them.



In addition Mrs. Hernandez should post all pages of the certified letter.

Mrs. Hernandez bringing up the counterfeit document is her praying that the Commission once again protects them.

I have a feeling that there will be a different outcome for EC-2023-0395 once the document in question gets examined by the Appeals Court.

In fact if she really wants, we can also have the Appeals Court tackle on matter EC-2024-0372 and they can examine all the paperwork that shows my payments cleared and that Ameren Missouri tampered with their own meter to upsell higher service charges.

As an FYI, Ameren Missouri openly admitted in their answer that they have no intention to settle what I've disputed, yet instead of resolving the issue, they demand payment for it.

That isn't how a dispute works.

Last, if Mrs. Hernandez read properly when I dismissed EC-2024-0217 it didn't further allow them to put any deposits etc, back on my account without solving them. Since there was no decision handed down by the Commission regarding EC-2024-0217, any matters that weren't satisfied or resolved by Ameren Missouri and I doesn't constitute Ameren being able to add those back to my account.

Maybe Mrs. Hernandez would like me to refresh her memory on EC-2024-0217 on May 10, 2024.

"Ameren Missouri must still decided on that. However if Ameren Missouri continues to submit counterfeit documents, continues to try and bill me for the deposit after the closure of my dismissed complaints and continues with their threats against me or harasses me wfor unfair balances, I won't file a Commission Complaint, but I will file a lawsuit in Circuit Court to have them deregulated and file suit against the Commission to have their authority taken away."

May 13, 2024, another filing on my end was uploaded through EFIS. I specifically states.

"Ameren Missouri has 30 days from the date of this letter to reach out to me or I will use all legal remedies and strategies in maintaining my best interest under applicable State and Federal Statutes in any further recourse.

If anything Ameren Missouri in their answers has openly admitted that they failed and purposely ignored any and all disputes that have arisen.

I think its time for Ameren Missouri and their legal counsel to actually tell the truth. I know I've threatened lawsuits in the past, but this time I really mean it. I think Ameren Missouri needs stern prosecution and that their legal dozers are going to continue the same roundabout of illegal tactics until the Court of Appeals gets involved.

If the Commission and Ameren see better we can just package both EC-2023-0395 and the counterfeit documents that Ameren utilized along with theri fraudulent meter tampering and along other matters brought up in EC-2024-0372 to the Appeal Court and let them make a position or ruling on that?
