**STATUS REPORT**

**COMES NOW** Confluence Rivers Utility Operating Company, Inc., (“Confluence Rivers”) and for its *Status Report* states as follows to the Missouri Public Service Commission (“Commission”):

1. On March 27, 2024 (effective April 26, 2024), the Commission issued its *Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity* (“Order”) in this case. The Order approves the transfer of, and grants a Certificate of Convenience and Necessity for, the water and sewer assets of the Lake Sherwood Estates Association (“Lake Sherwood”).

2. Among other things, the Order required Confluence Rivers to submit tariff sheets for the Lake Sherwood service area to become effective before closing on the assets and to notify the Commission of closing on the assets in this case or file a status report if closing has not yet occurred.


3. On May 30, 2024, Confluence Rivers submitted proposed tariff revisions to address the Lake Sherwood service area. Those tariff sheets became effective on June 30, 2024.

4. Confluence Rivers has not yet closed on the assets of Lake Sherwood but continues to work toward such closing.

5. Confluence Rivers will provide notice of closing on the assets to the Commission as soon as the assets of Lake Sherwood are closed upon.

WHEREFORE, Confluence Rivers respectfully submits this *Status Report* to the Commission.
