**PUBLIC COUNSEL’S MOTION TO MODIFY BRIEFING SCHEDULE**

**COMES NOW** the Office of the Public Counsel and for its Motion to Modify Briefing Schedule states as follows:

1. At the close of the evidentiary hearing, the presiding officer set the due date for initial briefs as February 21, on the assumption that the transcript would be available on February 7. In fact, the transcript was not posted in EFIS until February 11, four days later than was assumed when the briefing schedule was established.
2. Public Counsel requests that the briefing schedule be modified accordingly, so that initial briefs will be due on February 25, and reply briefs will be due on March 11.
3. There is no statutory deadline for Commission action, so this brief delay will not affect the Commission’s ability to deliberate and decide this matter. Furthermore, all parties either support or do not oppose this request.

**WHEREFORE**, Public Counsel respectfully requests that the Commission modify the briefing schedule and set February 25 and March 11, 2014 as the respective deadlines for initial and reply briefs.
