ORDER APPROVING REVISED TRANSPORTATION SERVICE TARIFF SHEETS

Issue Date: July 24, 2024 Effective Date: August 3, 2024

On March 6, 2024,¹ Spire Missouri Inc. d/b/a Spire filed tariff sheets (Tracking No. JG-2024-0124) to change Spire's transportation tariff language for gas service.

On March 11, the Commission's Staff (Staff) requested the Commission suspend Spire's tariff sheets to allow time for discovery and to allow time to analyze the required data and information and complete its investigation. On March 11, the Commission directed Staff to file its recommendation by July 11. On March 21, the Commission suspended the tariff sheets until August 3.

Spire filed substitute tariff sheets on July 8. On July 11, Staff filed its recommendation to approve the tariff sheets. No other responses to the tariff sheets or to Staff's recommendation were received.

The Commission has reviewed Spire's tariff sheets and Staff's verified recommendation. Based on these filings, the Commission finds that the tariff sheets are

in compliance with the Commission's previous orders and Spire's current tariff provisions and should be approved.

So that this order can be effective at the same time as the tariff sheets being approved, the Commission finds it reasonable to make this order effective in less than thirty days.

- 1. Tracking No. JG-2024-0124, as substituted on July 8, 2024, is approved to become effective August 3, 2024.
