ORDER GRANTING APPLICATIONS TO INTERVENE AND SETTING A DEADLINE FOR SUBMISSION OF A PROPOSED PROCEDURAL SCHEDULE

On July 23, 2024, the Commission held a procedural conference to discuss parameters for a proposed procedural schedule. At that conference, the Regulatory Law Judge asked if Union Electric Company d/b/a Ameren Missouri, the Commission's Staff, or the Office of the Public Counsel needed additional time to vet any of the timely filed intervention applications or whether there were any objections to granting those interventions. No party asked for additional time or objected to granting intervention to Missouri Industrial Energy Consumers, Sierra Club, Consumers Council of Missouri, Renew Missouri, AARP, Metropolitan Congregations United, and Midwest Energy Consumers Group.

Commission Rule 20 CSR 4240 2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The applications satisfy the requirements of Commission Rule 20 CSR 4240-2.075 and serve the public interest. The Commission will grant interventions.

The Commission also directed the parties to submit a proposed procedural schedule based upon parameters discussed at the procedural conference, no later than August 7, 2024.

This order memorializes the determinations made at the procedural conference.

THE COMMISSION ORDERS THAT:

- 1. The applications to intervene filed by Missouri Industrial Energy Consumers, Sierra Club, Consumers Council of Missouri, Renew Missouri, AARP, Metropolitan Congregations United, and Midwest Energy Consumers Group are granted.
- 2. No later than August 7, 2024, the parties must jointly submit a proposed procedural schedule or a status report informing the Commission when a proposed procedural schedule will be filed.
 - 3. This order is effective when issued.
