COME NOW, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“EMM”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“EMW”) (collectively, “Evergy” or “the Company”) and, for its *Response* (“Response”) to the Missouri Public Service Commission’s (“Commission”) *Order Setting Deadlines for Submission of Customer Data* (“Order”)¹ issued on June 28, 2024, states as follows:

For example, there is a small set of non-AMI meters that do have significant usage for certain rate codes that will not be accounted for in the above data. The Company is willing to discuss these issues in a future meeting with Staff for the Commission and the Office of the Public Counsel.
