**ORDER GRANTING FURTHER EXTENSION OF TIME**

On April 18, 2024,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the acquisition of the unregulated sewer assets of Barbara E. Rampone located in and around the Timber Ridge subdivision in Johnson County, MO (Timber Ridge). The Commission directed a recommendation or a status report from its Staff (Staff) no later than June 11, later extended to July 25.

On July 23, Confluence Rivers and Staff filed a request for a further extension of time. Confluence Rivers stated that it believes that the expectations of the Missouri Department of Natural Resources may require more immediate action than originally thought. Accordingly, there likely will be implications as to the rate proposal; therefore, Confluence Rivers plans to file a request to amend its application to address this issue.

Confluence Rivers and Staff requested an additional 60 days after Confluence Rivers files its amended application. The Commission finds the request reasonable and will grant the extension.

However, as Confluence Rivers has not yet filed its amended application, the Commission will grant a 60-day extension counted from the July 25 due date. If this time frame proves insufficient, the parties are free to file a request for an additional extension of time.

**THE COMMISSION ORDERS THAT:**

1. The request for an extension of time is granted. Staff shall submit its recommendation or a further status report no later than September 23, 2024.
2. This order shall be effective when issued.
