ORDER RECOGNIZING NAME CHANGE

Issue Date: July 26, 2024

Effective Date: August 5, 2024

On June 27, 2024,¹ United Services, Inc. requested that the Commission recognize its name change to United Fiber, LLC d/b/a United Fiber MO, LLC and approve its tariff adoption notice and revised tariff title sheet. The tariff adoption notice and revised tariff title sheet were assigned Tracking No. JS-2024-0175, and were originally filed with an effective date of August 1, later changed to September 1.²

On July 15, the Staff of the Commission (Staff) filed its recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommended the Commission recognize the name change and approve the tariff adoption notice and revised tariff title sheet. No responses to Staff's recommendation were received, and no other responses to the application of United Services were filed.

The Commission will recognize the name change and approve the tariff adoption notice and revised tariff title sheet.

P.S.C. MO No. 3 Original Sheet No.1 cancelling P.S.C. MO No. 2

4. This file shall close on September 2, 2024.
